## <u>Contract Agreement</u>

- The signer of the contract and the child shall abide by all of the rules and regulations of Learn & Play Center, Inc. and all of their year-round programs, including but not limited to Child Day Care, School-Age Child Care, Pre-K, Summer Camps, Football Camp, Baseball Camp, Before & After School Programs, Youth Clubs, Teen clubs and camps, and passenger transportation rules.
- 2) Parent/Guardian must furnish evidence of the child's satisfactory health including immunizations, and children must be approved by a physician to participate in child day care. The physician must complete fully the Child In Care Medical Statement form LDSS-4433 (Rev.5/2014) provided by NYSOCFS
- 3) Notice of cancellation must be by certified mail, return receipt requested and received by Learn & Play Center, Inc. on or before thirty days to start date. If such notice is not received by that date, the signer will be obligated to pay the full camp tuition session that they are signed up for. All registration fees and deposits are non-refundable. Learn & Play Center, Inc. reserves the right to obtain a judgment against the signer for the amount due, as well as attorney fees, and to notify the credit reporting agencies of any default. Learn & Play Center, Inc. reserves the right to deenroll registered children for "any reason" without notice or warnings, for any reason including but not limited to child sustaining injuries, illnesses, and/or behavior problems on site, off site or while being transported. There will be no refunds given for any discontinuance by a child for any reason, including, but not limited to, "not adjusting", injuries, illnesses, or for Learn & Play Center's de-enrollment of a child. There will be no allowance and no right to apply tuition to a substitute child or to a different session.
- 4) Our hours are Monday through Friday from 7:00 a.m. to 6:30 p.m. Extended hours are offered for additional fees as we are open Monday through Friday 6:30am to 7:00pm
- 5) Trips: The signer gives permission for their child to attend and participate in all off-premises trips, including but not limited to parks, events, food courts, restaurants, Mc Donald's, Burger King, Wendy's, Pizzerias, stores, swimming, baseball, football, kickball, and sport activities.
- 6) It is understood that Learn & Play Center Inc. will determine the type of vehicle under the jurisdiction of the N.Y.S. Department of Transportation that will be used for transporting your child; which may include school bus, van, car Long Island Rail Road and/or public transportation. The signer understands that their child may be de-enrolled without notice for not following rules while being transported in any vehicle. The signor agrees that they have read and understand Learn & Play Center's Transportation Plan, located on the Parent's Bulletin Board on a NYSOCFS form 6020.
- 7) The signer authorizes Learn & Play Center, Inc. to obtain through physicians, licensed nurse, or licensed emergency medical technician, of its choice, such medical care and first aid as is reasonably necessary for the welfare of the child if he or she is injured or becomes ill during Learn & Play's care. Parents will always be notified of a situation as soon as the incident occurs.
- 8) Camp T-shirts are required to be worn daily for summer camp programs.
- 9) Scheduled trips and events may change due to inclement weather or rain without notice to parents.
- 10) Parent/Guardians supply lunch, juice and water daily for school age children.
- 11) Tuition includes daily snack and program supplies.
- 12) The signer permits Learn & Play Center & Camp programs to use any photographs whether they are individual or group pictures of their registered children for the purpose of display, school or camp brochure or for advertising for the school or camp in print, internet or commercial advertising without any monetary compensation to participant or parents.
- 13) Learn & Play Center, Inc. & Camp have the right to close early or permanently due to any emergency, which is not in our control. These emergencies may include the following: Heavy Sleet, Snow, Tornado, Hurricanes, Horrible Windy Conditions, or when advised by the national weather advisory or for Nassau County or State Emergencies.
- 14) The signer, participant and parent or legal guardian understands by signing this agreement that they agree to hold Learn & Play Center. Inc. and their staff, owners free and harmless of all liability due to any injuries acquired at camp, during camp, during transportation provided by Learn & play Center, Inc. and/or their staff.
- 15) Our summer camp is required to be licensed by the New York State Department of Health and is required to be inspected twice annually.
